- 1. SWEEPSTAKES DATES: The Sweepstakes begins at 12:00 a.m. Eastern Time ("ET") on September 1st, 2023 and ends at 11:59 p.m. PT on October 31, 2023 (the "Sweepstakes Period"). For purposes of these Official Rules, all times are given in Pacific Time.
- 2. B.
